

ILGA BOARD MEETING 9/15/25

Board members present: MJ Boscombe, Leslie Smith, Jan McCarthy, Lynda Jones, Cathy Engen, Betty Lauer, Barb Amedro, Joni Hiller, Ann Gavin, Karen Beltz, Sharon Behm and Sue Olson.

The meeting was called to order at 3:08 pm by President MJ Boscombe. She introduced Coby as the new head pro at Ironwood.

MJ discussed the proposed slate of officers with Sue Pedersen for the upcoming election which will be held November 20th. MJ will post the proposed list by October 19th. President: Sue Olson, VP: Karen Simon, Treasurer: Sharon Behm and Secretary: Vicki Scott.

Prior Minutes: The May minutes were approved via email and have been posted to the web site.

Treasurer's report/Budget review: Sharon had sent out the June/July treasurer's report and budgets via email and both were approved. There is an approximate \$2,000 from this years budget (money that may not be spent this year) that will carry over to the 2026 budget. There was a motion by Lynda to accept the August financials and Karen seconded the motion. The motion passed. MJ relayed the information that all chits and non member resident gift cards need to be used by 12/31/25. We will discuss holding the November and December chits that ILGA will issue at the October board meeting.

Tournament Chair: Leslie stated we will be transitioning to Golf Genius (GG) sign ups in the near future. MJ asked Leslie to draw up instructions for GG sign ups. She also will ask Mark Theisen if the Pro Shop will continue to contribute \$300 for the Low Net Championship winners.

Membership: Betty reported there were no new memberships since the May meeting. We have 155 full members, 14 handicap only members and 2 social members. The 2026 membership renewal will

open at noon on 10/1/25 through the AGA website. The fee will be \$135 for full membership and \$75 for handicap only. There is no longer an early sign up discount. There was also a question about whether we need to continue to use/track the local handicap number, it was decided to discuss this at the October meeting.

Lunches: Amanda was unable to attend the meeting. MJ reported that Amanda has set up an expanded salad bar for the member/guest tournament in early December. MJ will work on setting up the low net award luncheon.

AGA/State Medallion: Joni reported that Dari Akin is the gross winner and Julie Clausen is the low net winner. Both have indicated they will play in the State Medallion Tournament January 9-11, 2026 at Oakwood.

Ringers/Birdies: Cathy reported on Birdie and Ringer payouts for the second session which ended August 31st. For Ringers, she paid out \$310 (48% participants) and for birdies, she paid out \$150, approximately 1/3 of those who scored birdies. There were a total of 194 birdies (good job ladies). Session 3 signups for ringers concluded on August 31st and she has collected \$320 from 65 participants. Cathy will be collecting ringer money in December for the first session of 2026 and asked if cash or Zelle is preferred. This will be discussed at the October meeting. It will be \$15 for the whole year or \$5 per session.

Pairings: Barb reported that the Pairings Committee has 5 well trained members and there are 3 resource people if there are any issues (Leslie Smith, MJ Boscombe and Barb Amedro)

Website: Ann was not present for an update and MJ reported there are currently no issues. There will be an upcoming post on the website regarding ILGA registration for 2026. Ann will review the Hubspot access requirements for the incoming board.

Karen and Jan seconded the motion and the motion passed.
