## ILGA Board Meeting November 17, 2025 Oakwood Library

The meeting was called to order at 3:00pm by MJ Boscombe.

The October minutes were reviewed. There was a motion by Karen to accept the amended minutes. There was a second by Sharon. The minutes were approved.

Treasurer's report/Budget review: The October financials were presented by Sharon. Sue made a motion to accept the financials and Ann made a second. The October financials were accepted. Sharon discussed the budget item of \$1,000 that has been set aside for any IRS issues in the future. Sharon suggested moving that money back into our general fund. Tournament Chair: MJ reported for Leslie that the GG (Golf Genius) tutorial was a big success and so far the implementation of GG during league play was going well. Next Thursday, before out shotgun start the installation of new officers will take place. Raffle tickets for the member/guest will go on sale and low net winner and flight champions will be announced during the luncheon after golf.

State Medallion: MJ reported for Joni that the gross and net champions from ILGA have been registered for the State Medallion tournament in early January, 2026.

Membership: Jean reported for Betty that as of 11/16/25 we have 92 full members, 6 new members and 2 handicap only members for a total of 100 members for ILGA going into 2026. Our total membership for 2025 was 171. Membership needs to be renewed by 12/20/25 to play in our first event in 2026.

Luncheons: MJ reported 40 people have paid and signed up for the low net champion luncheon on 11/20/25. The cost is \$28 per person.
